WHY 7-9?

This quarter we wanted to focus on why it is important to send patients for an evaluation between the ages of 7 and 9. We don't often make any treatment recommendations at this age, but there are several things we assess at our observation appointments. Growth patterns, missing teeth, crossbites, ectopic eruption of permanent teeth, warning signs for canine impaction, social concerns, habit cessation, and trauma risk are all things we are looking at in regards to our early to late mixed dentition patients. At Strickland Orthodontics, we feel very strongly that it is best for the patient and family from an efficiency, financial, and oral health standpoint to keep treatment in one phase if possible. Phase one treatment is often necessary for a variety of reasons, and we think educating our patients and their families is easiest done prior to the onset of more complex problems. We believe that timely education to families about the importance of orthodontic guidance and observation of their children prior to comprehensive care will set them up for success and help to avoid complex, elongated treatment in the future.

Phase I Treatment: Class III growth pattern/posterior, anterior crossbite/social concerns



15 year old presented with concern of OJ and alignment. Teeth appear relatively straight, but there is a severely impacted #13 and an impacted #2.











Premature loss of lower right second primary molar and lower left first primary molar. Key--- if you ever extract a lower second molar early, you 100% need a space maintainer! We used a distalizing spring with a lower lingual holding arch to distalize #30 and regain lost space.






Patient Examples cont.



15 year old presented with two impacted canines-- this is what we are trying to avoid!





7 year old presented with an ankylosed #19. Since significant eruptive potential remains, we plan to have #19 extracted and allow #18 to mesialize and hopefully erupt in its place.

12 year old presented all primary canines in place and impacted #11, #22 and #27. Earlier referral and extraction of all primary canines could have potentially helped us avoid this scenario.







13 year old with severely impacted upper canines. We recommended exposure to help canines erupt, but parents chose not to do the surgery due to fear of sedation. Flash forward 3 years later and impaction has become more severe.

The authors proposed that extracting the primary canine before the patient is 11 years of age would normalize the erupting position of the permanent canine in 91 percent of the cases if the crown were distal to the midline of the later incisor root. However, the success rate decreases to 64 percent if the permanent canine crown is mesial to the midline of the lateral incisor root.

Effects of lingual arch used as a space maintainer on mandibular arch dimension: A systematic review

Azzurra Viglianisi

- About 51% of the prematurely lost first deciduous molars and 70% of prematurely lost second deciduous molars cause loss of space and subsequent effects such as malposition or impaction of a permanent tooth in that quadrant, tipping of the first permanent molar, and crowding in the dental arch.
- Premature loss of deciduous molars has huge implications on space available for future eruption of permanent premolars. If this is necessary due to caries, either fabricating the space maintaining appliance in your office or referring to an orthodontist to assess need and fabricate the appliance is necessary in a timely manner.

Large overjet as a risk factor of traumatic dental injuries: a prospective longitudinal study

Jean-Paul Schatz, Enrico Ostini, Magnus Hakeberg and Starvos Killiardis

- If overjet is greater than 6 mm, you have 4x the likelihood of experiencing a dental traumatic injury.
- 93.4% of injuries occurred between ages 8-12 years old

Self-harm, dentofacial features, and bullying

- In Jordan, previous work has shown that 47.0% of children aged 11-12-years reported being bullied, with the most common feature targeted being teeth, specifically spaced or missing teeth, shape and color, and prominent maxillary teeth.
- In the present study, 21.8% of adolescents reported self-harm as a result of bullying targeted at their dentofacial features. Interestingly, the top 3 features identified for self-harm in this study; tooth shape and color, the gap between teeth or missing teeth, and "top front teeth stick out," were the same top 3 features targeted by bullies in several earlier studies.
